DIRECTIONS: From I-90 exit State Street (Business US 20) . Going west. Continue on State Street for 4.3 miles. Turn left at 29th Street this is just past a high rise (Valley View Apts. 3303 State Street) the park will be one block directly ahead of you.

From I-39 exit US20 bypass west, from US20 bypass (one mile) exit Alpine Road go north on Alpine Road (4.3 miles) to State Street. Turn left at State Street going west on State Street for (.8 tenths) of a mile. Turn left at 29th Street this is just past a high rise (Valley View Apts. 3303 State Street), the park will be one block directly ahead of you.

From US20 west, take Business 20 to Rockford, stay on Business 20 going east (8.6 miles). Turn right on 29th Street just past Temple Baptist Church and just before Valley View Apt high rise, the park will be one block directly ahead of you.
